# PRINCIPAL'S CORNER

Good day to each of you,

It was so wonderful to have so many families at Jefferson for conference week. Thank you for making time to sit down with our teachers and partner on how to make these last few months of the school year solid!

This week, I want to bring your attention to Jefferson's stance on discrimination. An earlier version of the information shown below has been included in most issues of The Jefferson Journal and can also be found in each family's Jefferson Family Calendar and Handbook that was sent home on the first day of school. This information, which is the same for all schools in the Spokane School District, details our stance against discrimination and steps that can be taken to report it.

Spokane Public Schools complies with all federal and state rules and regulations and does not discriminate in the admission, treatment, employment, or access to its programs or activities on the basis of age, sex, marital status, race, color, creed, national origin, the presence of any sensory, mental, or physical disability, to the use of a trained guide or service animal by a person with a disability, sexual orientation including gender expression or gender identity, or honorably discharged veteran or military status. This holds true for all students who are interested in participating in educational programs and/or extracurricular school activities, and provides equal access to the Boy Scouts and other designated youth groups.

### Kindergarten Registration Continues

Do you have a young scholar who will turn 5 before August 31st? If so, registration



is happening now. Families are encouraged to register online <code>Enroll/Enrollment Home</code> (spokaneschools.org). After your online registration is complete, you will be contacted about visiting Jefferson to complete the process. You will need to bring the following with you to the school:

- 1. A *birth certificate* or other official verification of age (such as a passport or visa) is required for students who have not previously enrolled in school. Kindergarten students must be 5 on or before Aug. 31; first graders must be 6.
- 2. <u>Medically verified immunization</u> <u>records</u> for new students.
- 3. <u>Part B Health Record</u> filled out for new students.
- 4. Proof of residency. This can be a current utility bill.
