CALL FOR RESOURCES CFR 2223-04 **CONTENT -K-12 Tier 2 and 3 Social Emotional Learning**

Spokane Public Schools is looking for a behavior, social skills Social Emotional Learning curriculum for our K-12 teachers and students needing tier 2 and 3 interventions. The curriculum must align to the Social Emotional Learning Standards, Benchmarks, and Indicators. The District expects the approved product would be fully implemented and in place for the start of the 2023-24 school year. Program field testing may be required depending on responses, schedule to be determined.

Elements Required:

- Evidence-based Social Emotional Learning, Social Skills and/or behavior skills curriculum including:
 - A wide variety of prosocial skills
 - Lesson plans and activities
- Content that is non-partisan, equitable, culturally responsive, and free of bias – perspectives and contributions from members of diverse groups are infused substantially, accurately, and respectfully; content is free of generalizations, stereotypes, and misrepresentations.

Elements Desired But Not Required:

- Ability to distribute content in print and pdf or online format
 - Easily accessible content for teachers and students
 - Ability to keep content up to date
 - Forms and handouts that are downloadable
 - The option for student workbooks, hands on activities
- Multitude of delivery styles (whole group, small group, individualized, independent options).
- Built in screening and progress monitoring
