It is recommended that a Purchase Order be awarded to <u>Consolidated Electrical Distributors, Inc</u> in the amount of <u>\$432,000</u> for the purchase of LED Lamps

BACKGROUND

The District is participating in Avista's Interior Commercial Lighting Incentive Program for the purpose of replacing fluorescent lamps district wide with energy efficient LED lamps. The lamps purchased will be compatible with all current fixtures. This purchase is for 75,000 lamps, and because of the volume there will be deliveries of 15,000 lamps scheduled every three weeks, beginning the week of November 7th with the final fifth delivery provided the week of January 30, 2017. This purchase is for materials only and installation will be handled seperately.

There were a total of fifteen vendors that provided bids on the lamps. Four vendors did not supply the required sample lamps, and after testing and evaluating all lamps that were provided, six of the lamps were not compatible with the districts existing ballasts. Of the five compatible lamps, Consolidated Electrical was deemed the low responsible and responsive vendor.

In participating in Avista's Incentive Program, Avista will provide a rebate to the District in the amount of up to \$15 per lamp to include all costs associated with labor, material and disposal of the old lamps. Further, it is anticipated that by installing these energy efficient LED lamps, the District will realize a substantial savings in its overall energy costs.

This award will be funded with general fund dollars and is scheduled to be substantially completed by January 31, 2017.
