Base bids will be received until 2:00:00 p.m. and held until 3:00:00 p.m. Alternates and List of Subcontractors will be received until 3:00:00 p.m. and will be opened and read at that time along with the base bids. Bids received after the above times will not be considered.

General Contractor Bidders may have two (2) sets of documents. Mechanical and Electrical first tier subcontractors may have one (1) set of documents. Additional or partial sets may be purchased at their own cost from Abadan Reprographics. The deposit will be returned to the unsuccessful bidders on receipt of plans and specifications for a period of ten days after opening of bids, provided the documents are complete and in clean and usable condition.
