Sealed bids will be received by the Purchasing Services Department of Spokane Public Schools at 2815 East Garland Avenue, Spokane, WA, 99207, for the following Public Works project:

Base bids will be received until 2:00:00 p.m. and held until 3:00:00 p.m. Alternates and List of Subcontractors will be received until 3:00:00 p.m. and will be opened and read at that time along with the base bids. Bids received after the above times will not be considered.
