#### **Recommendation:**

It is recommended that a contract be awarded to Halme Cascade General Contracting, LLC in the amount of \$2,536,000.00 for the Libby Center classroom remodel project to include the base bid amount as well as Alternates 1 and 2A.

## Background:

The Libby Center classroom remodel project consists of an approximately 13,000 square foot remodel of existing training spaces, meeting spaces, and offices on the west end of both the first and second floors into 11 new classrooms, four breakout spaces, and a staff workroom. All work meets the standard educational specifications set forth by the School Board in 2005 and updated in 2020.

Halme was deemed the low responsible and responsive contractor. Halme has worked in the Spokane area for many years. They were most recently the contractor on the Mullan Road Elementary School addition project.

This project will be funded with 2018 bond dollars with work scheduled to begin on or about June 23 and the work will be done in two phases with Phase 1 (the second floor) set to be substantially complete on or before August 27, 2021, and Phase 2 (the first floor) set to be substantially complete on or before October 15, 2021.

It is further recommended that the Board authorize a construction contingency for this project in the standard amount for remodel construction of eight percent (8%).
