Spokane Public Schools (SPS) is requesting the submittals from licensed Architectural and Engineering firms interested in providing professional services for the Sacajawea Middle School and South Hill Middle School projects. Required services include educational specifications development, schematic and design development, construction document preparation, permitting services, construction administration, and closeout.
