Please remember to do your health check each morning before 8:00 a.m. Download the SPS app on your smartphone or go to spokaneschool.org/attestation. If you are a parent or visitor, you also need to fill out a health attestation to enter the building. Just go to the Madison website and fill out the "visitor health check" under the "community" tab.

The 4th graders had a special guest, Laurie Nisbet, from NOAA (National Oceanic and Atmospheric Administration) to talk to our kids about how she determines the weather and administers weather watches and warnings. It was connected to our PBU and our essential question about "What are the benefits of studying the weather?" It was also well timed after the wind days we had.

Please be mindful when dropping off and picking up your children at school. We are short handed on crossing guards and are asking you to be respectful of the adults crossing and to follow our school safety guidelines by using the crosswalks when crossing the streets. Also, when driving, please



slow down and pay attention to the crossing guards by stopping when the flags are out and proceeding through the intersections with extreme caution. Together we can make sure that all our students are safe! Thank you!
